PRIVACY

The Association of British Riding Schools (ABRS) is committed to protecting your privacy and on being transparent about how we process personal data. We will only use the information collected from you in a manner that complies fully data protection legislation.

We will not divulge your information to any third party now or at any time in future without first asking for your permission. You can check and change any information that we hold by contacting the ABRS Office (see Contact Details below).

We do not store your credit card details.

INFORMATION WE MAY COLLECT FROM YOU

We may collect and process the following data about you:

Information that you provide by filling in forms. This may be paper forms that are submitted by post, or online forms submitted through our website (<http://www.abrs-info.org>) (the "Site"). These forms will include information that is provided on becoming or renewing as a member of ABRS, through use of the Site Contact Form, or where we are providing goods or services to you. We may also ask you for information when you report a problem with the Site.

If you contact us, we may keep a record of that correspondence. The ABRS may also ask you to complete surveys that we use for research purposes, although you do not have to respond to them.

IP ADDRESSES AND COOKIES

We may collect information about your computer, including where available your IP address, operating system and browser type, for system administration and to report aggregate information to our advertisers. This is statistical data about our users' browsing actions and patterns and does not identify any individual.

For the same reason, we may obtain information about your general internet usage by using a cookie file which is stored on the hard drive of your computer. Cookies contain information that is transferred to your computer's hard drive.

You may refuse to accept cookies by activating the setting on your browser which allows you to refuse the setting of cookies. However, if you select this setting you may be unable to access certain parts of the Site. Unless you have adjusted your

browser setting so that it will refuse cookies, our system will issue cookies when you log on to the Site.

WHERE WE STORE YOUR PERSONAL DATA

The ABRS will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

Where we have given you (or where you have chosen) a password which enables you to access certain parts of the Site, you are responsible for keeping this password confidential. We ask you not to share a password with anyone.

Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to the Site; any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.

DISCLOSURE OF YOUR INFORMATION

We may disclose your personal information to third parties where we are under a duty to disclose or share your personal data to comply with any legal obligation, to enforce or apply our terms of use and other agreements, or to protect the rights, property, or safety of the ABRS, our members or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.
